**WAYNE COUNTY FISCAL COURT
ORDINANCE NO. _____**

**AN ORDINANCE CREATING A COUNTY CEMETARY BOARD FOR
PURPOSE OF RESTORING AND MAINTAINING NON-PROFIT
CEMETARIES**

SUMMARY

The Fiscal Court of Wayne County having an interest in cemetery preservation, genealogy and local history does hereby create a Board of five volunteer members for purposes of preserving non profit cemeteries that do not receive perpetual care funds. This Board has the authority to accumulate and administer funds including the ability to apply for and receive appropriations, gifts, grants, federal funds, revolving funds and any other funds from public and private services to be used for actual expenses incurred in the preservation of cemeteries located in Wayne County, Kentucky.

**BE IT ORDAINED BY THE FISCAL COURT OF WAYNE COUNTY,
COMMONWEALTH OF KENTUCKY AS FOLLOWS, TO WIT:**

Pursuant to the authority of KRS 67.680 the Fiscal Court of Wayne County does hereby create a county cemetery board with authority in it's name to accumulate and administer pecuniary funds including the ability to apply for and receive appropriations, gift grants, federal funds, revolving funds and any other funds from public and/or private sources for the purpose of restoring and

maintaining nonprofit cemeteries that do not have a source for perpetual care funds.

This Board shall consist of five volunteer members who have resided in Wayne County for at least one year prior to their appointment and have demonstrated an interest in cemetery preservation, genealogy and/or local history. The Board shall consist of five volunteer members no more than three (3) representing the same political party. The initial Board shall consist of one member appointed for a one year term, one member appointed for a two year term, one member appointed for a three year term and two members appointed for four year terms. Upon expiration of these initial terms their replacements shall serve a four year term. There is no limit to repeated terms of service. The Board shall meet at least three (3) times annually in space provided by the fiscal court.

The Board shall expend all funds in compliance with administrative regulations promulgated by the Governors Office for Local Development regarding grant applications, eligible expenditures accountability and reporting procedures.

SEVERABILITY

Each section and each provision of each section of this ordinance are severable, and if any provision, section, paragraph, sentence or part thereof, or the application thereof to any person, class or group, is held by a court of law to be unconstitutional or invalid for any reason, such holding shall not affect or

impair the remainder of this ordinance, it being the legislative intent to ordain and enact each provision, section, paragraph, sentence and part thereof, separately and independently of the rest.
